## Review of the previous meeting

 Webinar focusing on admission – Principals/Coordinator/HOIs (pending since last two Coordination meeting)

Dean Sikkim Manipal Institute of Medical Sciences (SMIMS) informed that as far as MBBS admission is concerned Webinar is not required. 502 applications for 100 seats have already been received.

Principal Sikkim Manipal College of Nursing (SMCON) informed that institute has received very good response for admission to B.Sc Nursing. 210 application have been received, out of 100 seats 20 from Govt of Sikkim 39 already filled up remaining seats to be filled up by the end of August therefore webinar for admission is not required.

Sikkim Manipal College of Physiotherapy (SMCPT) has also filled up more than 60% of seats and there is no plan to host webinar

SMIT is organizing webinar on almost weekly basis.

Hon'ble Vice Chancellor suggested to maintain timeframe as per regulatory bodies by all units.

Asst Registrar, IQAC informed the house that SMIT has already registered for the membership of UBA. Supplementary examination for final year students will be held as per the advisory received from MCI and INC.

**Dy Controller Exam (Tech):** As per SOP of the University all the examinations were conducted for B.Tech, M.Tech, BCA, MCA, BBA, MBA and MSc courses. Results have also been published. Major project of B.Tech final year students to be evaluated online, accordingly results to be declared.

Intimation received from MCI on 4 Aug 2020 to conduct examinations. Date for examinations to be finalized. As per direction of the Govt of Sikkim regular students of the University will be called.

Director SMIT informed that presently 33 students residing in the campus. Online classes are in full swing for all the courses.

Principal SMCON informed that 19 B Sc Nursing students (batch 2019-2020) from outside the state have reported for final exams and have completed

their quarantine. As per the guidelines of the Indian Nursing Council exams will be conducted in the month of September.

HOD, Department of Microbiology, SMIMS briefed that infrastructure and equipment are ready for COVI-19 testing at CRH. SMIMS staff have been sent to STNM hospital for the training. BSL 2 laboratory is ready for operation and testing kits are ordered. Eventually, awaited NABL accreditation to carry out testing.
