Principal SMCON informed that digital material is prepared for online admission however SMCON is giving more focus on offline admission. Total budget allocation for admission for SMCON is not yet received.



Hon'ble Vice Chancellor suggested to enable online payment portal for HSS admission and directed to consult SMIT Admission Officer for online admission.

Online Viva-Voce exam for MHA students to be carried out through Skype or Microsoft teams subject to presentation and evaluation of thesis is completed. External examiner to be identified and finalised the date for examination in consultation with DCE, SMU.

**Following UGC Guidelines on Examinations and Academic Calendar for the Universities in view of COVID-19 pandemic and subsequent lockdown represented by Registrar, SMU**

- a) Institute to adopt an alternative and simplified modes and methods of examinations to complete the process in shorter period as prescribed by UGC. These may include MCQ based examinations, assignment/presentation-based assessments.
- b) All institute to adopt efficient and innovative modes of examinations by reducing the time from 3 hrs to 2 hrs assigned to each examination, if need arises without compromising on the quality, so that the process may be completed in multiple shifts and, at the same time, sanctity to evaluate the performance of student is also maintained.
- c) Grading of the students could comprise of 50% marks based on pattern of internal evaluation adopted by the universities and the remaining 50% marks can be awarded on the basis of performance in previous semester only (if available). The internal evaluation can be continuous evaluation, prelims, mid semester, internal assignments.
- d) In situation where previous semester or previous year marks are not available, particularly in the first year of annual patter of examinations, 100% evaluation may be done based on internal evaluation.
- e) If the student wishes to improve the grades, he/she may appear in special exams for such subjects during next semester
- f) In addition to the above, following steps are required to be taken

The scheme of "Carry forward" (for the subjects in which the student has failed) will be allowed for current academic year in the universities and every student will be promoted to next semester/year. However, such students may clear the examination for the course in which he/she has failed/remained absent. Whenever the examination is held next.



Regarding the requirement of minimum percentage of attendance for the students/research scholars, the period of lockdown may be treated as 'deemed to be attended' by all the students/research scholars.

The universities may conduct the practical examinations and viva-voce examinations through Skype or other meeting apps, and in case of intermediate semesters, the practical examinations may be conducted during the ensuing semesters.

The following calendar is suggested for academic session 2019-20

Conduct of examination:

- i) Terminal Semester/Year 01/07/2020 to 15/07/2020
- ii) Intermediate Semester/Year 16/07/2020 to 31/07/2020

Evaluation and Declaration of Result

- i) Terminal Semester/Year 31/07/2020
- ii) Intermediate Semester/year 14/08/2020

Admission to the UG/PG programmes for the session 2020-21 may be completed by 31 Aug 2020. If necessity arises, provisional admissions may also be made, and relevant documents of qualifying examination may be accepted up to 30 Sep 2020.

The above matter was discussed at length with all HOIs and members of the House.

Hon'ble Vice Chancellor recommended that all institute to follow the UGC guidelines for the future course of action except Medical and Nursing colleges.

Hon'ble Vice Chancellor encouraged to take provisional admission in all units excepting medical and nursing.

Head IT to ensure all the application received by IT Department to be immediately forwarded to the concerned department.

Separate mobile number for admission to paramedical courses to be facilitated and shared on the website.



Dean SMIMS Informed that SMIMS has successfully conducted counselling for MD/MS program. Admission to PG course completed on 28 & 29 April. 4 students have taken admission.

coordinate with all HOD concern and ensure that Dr Rustam's system is demonstrated to all department. All institute to follow user friendly and uniform system.

- Financial review of CRH for the last one month to have as soon as possible and have a review meeting.
- CRH has done many good activities like complex surgeries. The outcome of the activities to be updated in social media. CRH to promote themselves in social media in terms of patient related outcome and range of services provided. One column is reserved in Sikkim Express for publication of CRH activities and Services offered by CRH.
