Sub.: Recognition/approval of Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim for the award of MBBS degree granted by Sikkim Manipal University, Gangtok against the increased intake from 50 to 100 seats u/s 11(2) of the IMC Act,1956 - Reg.

Madam,

In pursuance of the directions of Hon'ble Supreme Court in SLP (C) No. 34220 of 2015 – Medical Council of India vs. Sikkim Manipal University & others, dated 09.07.2019 (copy enclosed), I am directed to inform you that in considering the matter with regard to recognition/approval of Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim for the award of MBBS degree granted by Sikkim Manipal University, Gangtok against the increased intake from 50 to 100 seats u/s 11(2) of the IMC Act,1956, it was observed from the records that the Sikkim Government has entered into Memorandum of Understanding (MOU) with the Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim for utilizing the STNM Hospital, Gangtok, Sikkim, for the purpose of clinical training of students admitted at Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim.

2. Therefore, the Council vide letter dated 17.07.2019 followed by subsequent reminder dated 24.07.2019 requested the State Govt. to submit an undertaking that the Sikkim Govt. will not withdraw the MOU with Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim with respect to STNM Hospital for another five years, in the event of grant of recognition to the college.

3. In reference to above, the Council received a letter dated 29.07.2019 from the Principal Secretary, Health Care, Human Services and family Welfare Department, Government of Sikkim, which reads as under:-

"This is with reference to your letter no. MCI-37(1)(UG)/2013-14-Med/ 130545; dated 17.07.2019 and telephonic talk you had with Chief Secretary, Sikkim, I am directed to inform you that Health Department, Govt. of Sikkim has agreed to provide new STNM Hospital for the purpose of clinical training of students admitted at Sikkim Manipal Institute of Medical Sciences, (SMIMS) only for a period of 02 (two) years, for the session 2019-20 and 2020-21.

Further, the State Government has also decided to start its own medical college from the session 2021-22. Hence, from year 2021-22, new STNM Hospital will act as a teaching hospital for the Government Medical College and the same Hospital will not be available for SMIMS.

SMIMS, has given as undertaking that their Central Referral Hospital will be made fully compliant by 30.06.2021 as per MCI regulation for 100 seats and then from 30.06.2021 they will not be needing new STNM Hospital for clinical training of their students.

Hence, I am directed to convey to you the recommendation of State Government that medical seats of SMIMS may be increased from 50 to 100 from this year only. State Government shall allow SMIMS to use the new STNM Hospital only for two sessions 2019-20 and 2020-21".

4. The matter was considered by the Board of Governors and it has been decided as under:

"The college has no deficiencies for infrastructure & clinical material when the STNM (Sikkim Govt) & CRH (SMIMS) hospitals are taken together. Further in view of the letter received from Secretary Health, Sikkim wherein they have indicated that the MOU is likely to be terminated after 2021 when they intend to start their own Medical College using the STNM facilities & withdraw the facility of STNM for SMIMS, and consideration for the students admitted thus for 50-100 increase in MBBS seats we may consider granting recognition for the increased intake from 50 -100 seats, however, the recognition so granted shall remain valid till the MOU regarding utilization of STNM Hospital between the State Govt. and SMIMS, Gangtok remains in existence"

5. In view of above, you are requested to issue necessary notification at the earliest recognizing Sikkim Manipal Institute of Medical Sciences, Gangtok, Sikkim for the award of MBBS degree when granted on or after March, 2015 till the MOU regarding utilization of STNM Hospital between the State Govt. and Sikkim Manipal Institute of Medical Sciences, Gangtok, remains in existence by Sikkim Manipal University, Gangtok against the increased intake i.e. from 50 to 100 seats. The matter relating to continuance of recognition of MBBS degree awarded by the said Institute shall be proceeded with in accordance with statutory provisions thereafter.




