MD (Psychiatry)

(This shall be a recognized medical qualification when granted by Sikkim Manipal University of Health, Medical and Technological Sciences, Sikkim in respect of students being trained at Sikkim Manipal Institute of Medical Sciences. Gangtok on or after 2015.)

Note: a. The recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.

b. Failure to seek timely renewal of recognition as required shall invariably result in

stoppage of admission to the Postgraduate Course.
