In compliance of order dated 27/04/2012 of the Hon'ble High Court of Sikkim in WP (C) No. 37 of 2011, I am directed to convey the approval of Board of Governors of Medical Council of India for renewal of permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 50 to 100 at Sikkim Manipal Institute of Medical Sciences, Gangtok for the academic year 2012-13 is subject to the outcome of the SLP filed by the MCI and following conditions/ stipulations:

- 1. The Letter of permission for increase of admission capacity is subject to the outcome of the Special Leave Petition filed by the MCl in the Hon'ble Supreme Court against the judgment and order of the Hon'ble High Court of Sikkim in WP (C) No. 37 of 2011;
- It is made clear that the letter of permission shall stand automatically withdrawn forthwith in the 11. event of special leave petition filed by the Board of Governors in supersession of Medical Council of India being allowed by the Hon'ble Supreme Court;
- In the event of Special Leace Petition filed by Board of Governors is allowed, the students admitted 111. against the increased admission capacity shall be discharged forthwith;

It is the duty of the college to make the student fully aware of the pending case and thereafter, it shall obtain undertaking from the students admitted against increased admission capacity that the students will not claim equity in the event of cancellation of admission and the student is taking admission voluntarily. The said undertakings shall be furnished to the Medical Council of India within 15 days of admission of the students admitted against the increased admission capacity; and
- The college undertakes to return the fee collected from the students admitted against increased V. admission capacity in the event of cancellation of admission in the circumstances mentioned above.

In addition to above, the college is required to submit documents/ proof about:

- "(i) AERB and PNDT approval.
- Availability of resident hostels. (ii)
- Faculty shortage is stated to be 16.7% _- 4-3 (ni)
- Operation theatre equipment is madequate, Respiratory gas monitor not available in any O.T. (iv)

The Board of Covernors has granted approval after consideration of the Assessment Report (16th & 17th March, 2012) submitted to Board of Governors of MCI. The Permission is, however, subject to the condition that admission process may be completed as per time schedule prescribed in the Regulations of Medical Council of India.
