Head Mr. Vikas Singh, learned senior counsel along with Mr. Gaurav sharma, learned counsel for the Medical Council of India, Ms. Pinky Anand, learned Additional Solicitor General for India and Mr. Gopal Subramaniam and Dr. A.M. Singhvi, learned senior counsel for the respondents. Be it stated, we had sought assistance from the learned Attorney General for India but as he has some difficulty, Ms. Pinky Anand, learned Additional Solicitor General has assisted the Court.

Having heard, learned counsel for the parties, we are inclined to permit the respondent-University to participate in the counselling that is going to commence 3.9.2016. Needless to say, any resultant effect of the counselling shall be subject to result of the special leave petition. The counselling shall take place for filling up of 50 seats. Be it clarified, the Medical Council of India had already granted recognition which is in vogue for 50 seats. We are granting permission for additional 50 seats as similar interim orders have been passed from time to time, regard being had to the special features of the case.
